




STAFF MEETING

The Commissioners met with Pam Eckhardt, Patty Walters, Ron Simmons, Dusty Whited, Scott Reese, Sheri Landon, David Lane, Eric Jackson, Allen Jensen, Shawn Hill, Cody Lewis, Cleve Colson, Jeff Gardner for Sheriff Craig Rowland, Barbara Marlatt for Tanna Beal, Laura Lora, Meranda Small, Tracy Reifschneider, Dan Eldredge, Danette Miller, Mayor Paul Loomis; Elected Officials, Department Heads and Supervisors for the regular monthly staff meeting. The Meeting was conducted by Chairman Carter.

Pledge of Allegiance: Chairman Carter

Minutes: There were no changes or corrections to the minutes for August; they were approved as written.

Commissioners: Chairman Carter explained that his son lives in Orlando Florida, he has been closely following the hurricane in the area.

Chairman Carter reviewed the letter that was included with last month's payroll giving an explanation of the benefits provided to Bingham County employees.

Commissioner Manwaring explained that today is Patriots Day, it's a day to remember those who have sacrificed for our county.

Clerk's Office: Pam Eckhardt stated that this is the last month of the fiscal year for the budget. She explained that she is preparing budget packets and thanked everyone for their efforts.

Payroll: Patty Walters thanked the Commissioners for the 1.5% Cost Of Living increase and covering the cost of the increase to dependent care. She reminded everyone that this month's cutoff for payroll is September 25th.

Ms. Walters added that beginning on Wednesday, September 13th she will be working at home until the end of the month due to medical reasons. Lynette George will be her backup while she is gone, please contact her with any payroll questions.

Ms. Eckhardt explained that the IT Department has purchased a laptop for Ms. Walters to use at home. This will be a secure laptop that will directly connect to her county computer.

Road & Bridge: Dusty Whited explained that due to the flooding, FEMA has shut down all of their smaller projects which includes the project in Bingham County. FEMA will resume with the Bingham County project next year.

Emergency Services/Parks and Recreation: Scott Reese explained that they estimate that there were 330,000 people who came to the area to see the eclipse on August 21st.

Human Resources: Dave Lane thanked the Commissioners for the generous benefits they provide the employees.

He explained that ICRMP Training due in January; open enrollment is until September 22nd; the flu shot clinic will be held October 5th from 3:00 p.m. to 6:00 p.m.

He stated that he would like to have pictures taken of all employees to add photos to the Human Resources management program Bamboo. He will work with department heads to coordinate getting these pictures taken.

He explained that service awards will be given in place of the Employee of the Month. Employees will be recognized in 5 year increments. Employees will be recognized once a month during Staff meeting.

Building Maintenance: Eric Jackson explained they have been working on the Prosecutor's Office Conference Room.

He stated that we are in a hard time of year to keep the building at a comfortable level, they are doing their best to make it as comfortable as possible.

Drug Court: Cody Lewis thanked the Commissioners for the benefits provided to the county employees. He explained that he has been working with the jail to find other avenues for offenders to keep them out of the overpopulated jail.

Sheriff's Office: Jeff Gardner explained that they are still having issues with overpopulation of the jail. He stated that they didn't have many issues with the Eclipse, there was just a lot of traffic in the area.

Extension Office: Meranda Small explained that they are hopeful that they will have a new Family and Consumer Sciences Educator in the next week. She added that they are very happy the fair is over.

Commissioner Manwaring thanked the Extension Office for all the work they do with 4H.

Weed Department: Dan Eldredge stated that they are beginning the slow season, they are now working on education workshops. He added that they try to keep all the events updated on the website.
